Terms of Submission to a DJR Exchange Live Auction Event

Terms of Submission to a DJR Exchange Live Auction Event. By sending in an Auction Submission form or any item for auction, you agree as follows:

1. You have legal ownership and full rights and authority to sell the item(s) you are consigning.
2. All statements you have made, including regarding the character, quantity, features, condition, authenticity, and history of the item(s) are accurate.
3. DJR Authentication has the exclusive right to sell the item(s) in the auction format and lot size DJR Authentication may elect, in its discretion, to list the item(s) in any other auction or remove the item(s) from an ongoing auction, with the goals of maximizing the sale price and ensuring the trust in the sale.
4. While the majority of transactions are completed, on very rare occasions, the buyer fails to remit payment. Should an item you submit go unpaid by the buyer, DJR Authentication will relist the item(s) for auction, separately or in a lot, until the sale is successful.
5. Under no circumstances, will an item(s) be pulled from an active auction, unless directed by law.
6. You recognize that it is impossible for DJR Authentication to accurately predict the ability to sell, selling price, or time of sale for any item(s).
7. You will indemnify, defend and hold harmless from and against any and all loss, damage, expense or liability (including without limitation court costs and attorney fees) arising out of or related to your consignment to DJR Authentication.
8. If any dispute arises between us, you agree that it will be resolved according to South Carolina law (without regard to conflicts of law principles) and that it will be resolved in the state or federal courts located in Charleston, South Carolina.

Items We Do Not Accept

Framed Items: All items larger than 16x20" must be removed from their frame before being submitted through the mail. Heavy Items: Single objects weighing more than 30 lbs. Larger items: Furniture, sporting goods or oversized, odd shaped items. Inauthentic or counterfeit items. Extremely fragile items. eBay Prohibited & Restricted Items (ebay.to/2G3SPBQ). If you are unsure about an item you'd like to submit, email us at djrpro.com. If we receive an item(s) that cannot be sold, due to auction restrictions, Consignor is responsible for return postage.

Reserve Price Terms & Conditions

Consignor can choose to set a Reserve Price (a minimum price), for each auction valued at \$1,000 or more, that must be met before a sale can be made. The Reserve Price fee, **9.75% of the Reserve Price**, will be deducted, along with the regular commission rate and eBay/PayPal selling fees, from the Consignor's auction proceeds once all auctions have closed. Each auction listing's Reserve Price will be set at 50% of the estimated fair market value, which will be determined by DJR Authentication. If you choose to add a Reserve Price, select "Add Reserve Price" on the Auction Submission Form. A Reserve Price will be added to all of your auctions valued at \$1,000 or more, when this option is selected. This fee applies whether or not your item sells.
